According to law, Gloria Botha School has compulsory school fees for each learner. The following terms and conditions are applicable:

1. Both the father and mother, and/or where applicable, any guardian of the learner is responsible for the payment of school fees.

2. ADVANCE DISCOUNT AMOUNT

A discount of 6% of the total amount will be granted should payment be made in full before 1 February of the academic year.

3. MONTHLY PAYMENT OPTION

Payments are to be made for 11 months – MONTHLY IN ADVANCE - no later than the 1st day of the 2026 school year (for January 2026) up to and including November 2026 (for November 2026).

4. NON –PAYMENT OF SCHOOL FEES

In the event of the parents failing to make any payment, Gloria Botha School shall have the right to demand the immediate payment of the total amount owing to the school and take the necessary steps for legal action to commence. Failure to adhere to the payment of school fees, will result in the suspension of the learner from school.

The parent further accepts that in such circumstances as stated above due to non-payment, the parent shall be liable for the payment of all legal fees on the attorney and client scale of costs, including collection commission and interest incurred by Gloria Botha School in demanding and enforcing compliance with the parent's obligations in terms hereof. In such a case both parents' personal information will be disclosed to a Collection Agency or lawyer's offices for the fees to be collected successfully.

In terms of the law parents are jointly and severally liable for the payment of the school fees irrespective of their marital status. In the event of non-payment of school fees, the school will sue or list both parents irrespective of maintenance and court orders which may exist between the parties.

PLEASE NOTE:

- One calendar month's written notice is required when a learner is leaving Gloria Botha School.

- No refund will be considered due to being on holiday, sickness or closure of school due to unforeseen circumstances, such as an outbreak of a pandemic (e.g., Covid-19), riots or strikes.

5. It has been decided at the Annual General Meeting that the school fees for 2026 will be R2 600 per learner per month for 11 months. **No cash payments can be made at the school. Due to the high bank charges that the school must pay for cash deposits, you must make use of electronic transfers or stop orders.**
